NARRATIVE

While working the 2006 World Series ticket scalping detail in an undercover capacity, I approached the offender, Andrew T. and asked if he had any tickets for sale. Andrew T. acknowledged he did and produced 14 tickets for Game 5 (Section 446, Row 6, Seat 2.3.4.5, Section 246, Row 3 & 4, Seat 9, 10, 11, 9, 10, Section 134, Row 23, Seat 3, 18, 19, Section 509, Row 22, Seat 11,12) . He stated he would sell the tickets to me for \$ 550.00 a piece.

After observing the tickets were \$ 150.00 a piece, I produced my department badge and verbally identified myself as a police officer. I advised Andrew T. he was in violation of city ordinance by selling tickets over face value.

Andrew T. was issued a summons for `Resale Ticket Too High` and released.

Four World Series tickets for Game 5 were seized as evidence.

No evidence has been located in the Property Custody LIMMS System per PO Brett Zolla, DSN 5590, though the report indicates the ticket was placed in Property Custody. The ticket was not found in Division property room when audited by Captain Hayden and Lieutenant Huelsmann.

The summons was not entered, there was no warrant

application scanned and no City Court information was found.

NOTATION:

This case was reported in the Post Dispatch on 3/23/07. Faulkner came to the Office on 3/26/07 to file a complaint. Faulkner stated he was at 10th & Pine where he met the sons of his friend Michael Toolen, to give them a pair of tickets that he had received from a mutual friend, Ray Battistini. The sons, Andrew and Timothy Toolen, met Faulkner and received the tickets. They also gave Faulkner the face value of the tickets so that he could give the money to Battistini.

As the Toolens started to walk away, two plain clothes officers ran up and told Faulkner that he was under arrest for scalping tickets. Faulkner said one of the two officers removed an envelope from his shirt pocket which contained a baseball ticket for the day's game and a baseball card. Faulkner advised that the baseball card and ticket the officers' had seized had been sold over Ebay to a subject from Kansas City named Tim Roach and that he was meeting Roach before the game. (Faulkner supplied the Ebay sale page for item 6566270628 showing the ticket and a baseball card had been sold on October 3, 2005. The section, row and date of the ticket were listed but the seat was not listed on the Ebay page. Faulkner explained that he is not allowed to post the seat location on Ebay, but provided the seat number, 21.)

Faulkner said the officers walked him down the street to a black SUV parked near TGI Fridays bar and grill where one officer wrote him a summons, while the other officer walked over to a blond white female. The officer who was talking to the female apparently knew her as he was sharing a beer with her. After giving him a summons, Faulkner said the officers let him leave.

Faulkner said he went back to the location where he was supposed to meet Tim Roach. When Roach arrived, he advised Roach what had occurred and refunded his money for the tickets and the delivery fee. Faulkner said he was relieved as Roach told him that he had already obtained two tickets to the game for him and his son.

Faulkner said he then went to the game with the ticket he had in his back pocket and checked the seat for the ticket the officers had seized. There he observed the white female the officer had been speaking to in front of TGI Fridays.

Faulkner said he appeared in City Court on the date and time specified on the summons and was informed that his name was not on the docket. Faulkner said he contacted a friend who works with the Department and had them check and see what happened with his arrest. The subject told him there was no record of his arrest.

Tim Roach was contacted and he stated that he had purchased a baseball card and a baseball ticket to Game 2 of the Divisional Playoffs on Ebay from Jim Faulkner. Roach said he had planned to go to the game by himself, but when his son could go, he purchased two additional tickets from another individual over Ebay. (Verified through Ebay) Roach said that when he arrived at the pre-arranged meeting place he was met by Faulkner who apologized to him, stating that the ticket and baseball card he had purchased over Ebay had been seized by the police. Roach said Faulkner reimbursed him for the baseball ticket, baseball card and the cost of shipping. Roach said he then walked over to the stadium and arrived just prior to the game starting.

Andrew Toolen was contacted and he stated he had met his father's friend, Jim Faulkner, before Game 2 of the playoffs and received 2 tickets from him. Toolen said he and his brother gave Faulkner the face value of the tickets. As they were walking away, a plainclothes officer came up and displayed a badge. The subject began questioning Faulkner about their transaction. When the officer observed them standing nearby, the

officer told them to move on as it did not concern them. Toolen did not witness anything further. Toolen said he and his brother then went to the stadium and arrived at the beginning of the first inning.

Timothy Toolen was contacted and corroborated his brother statement. Timothy Toolen believes they arrived at the stadium at the beginning of the first inning, but he could not be sure as he has attended numerous Cardinal games and he maybe confusing the time frame with another game.

Ray Battistini was contacted and confirmed that he gave Jim Faulkner two tickets to Game of the playoffs. Battistini said he had purchased the tickets, however, the game was a day game and it interfered with work. Battistini asked Faulkner if he knew anyone who would like the tickets and Faulkner arranged to sell them to Michael Toolen's sons for face value. Battistini said he believes the tickets were in the bleachers, left field, Section 593. He said they were in the upper rows probably rows 24 or 25.

A preliminary investigation ascertained the incident was reported under CN 05/080010 and Officer Michael Ehnes, DSN 5628, is the reporting officer. Officer Thomas Kitchell, DSN 4974, is listed as the assisting officer. The report indicates that James Faulkner was arrested for "Scalping" at 119 Pine (It should be noted that the address of 119 Pine does not exist. This location would be on the Arch Grounds near the south legs of the Arch.) at 1447 hours on October 6, 2005. One baseball ticket to Game 2 of the Division Series, Section 228, was seized. According to the report, the ticket was placed in property custody. The report had a copy of the summons scanned, however, there was warrant application form scanned into the system. The summons had a complaint number; however, no tracking number was on the summons. A check with Rejis found no summons tracking number for James Faulkner. Assistant City Counselor David Miller was contacted and he checked the City Court files and did not find an City Court entry for James Faulkner, white male,

INVESTIGATIVE INFORMATION: (Example: Additional Complainants, Additional Employees, Interviews, etc.)

Additional Employee named in the complaint - Det. Thomas P. Kitchell, DSN 4974

This case was reported in the Post Dispatch on 3/23/07. Faulkner came to the Office on 3/26/07 to file a complaint. Faulkner stated he was at 10th & Pine where he met the sons of his friend Michael Toolen, to give them a pair of tickets that he had received from a mutual friend, Ray Battistini. The sons, Andrew and Timothy Toolen, met Faulkner and received the tickets. They also gave Faulkner the face value of the tickets so that he could give the money to Battistini.

As the Toolens started to walk away, two plain clothes officers ran up and told Faulkner that he was under arrest for scalping tickets. Faulkner said one of the two officers removed an envelope from his shirt pocket which contained a baseball ticket for the day's game and a baseball card. Faulkner

advised that the baseball card and ticket the officers' had seized had been sold over Ebay to a subject from Kansas City named Tim Roach and that he was meeting Roach before the game. (Faulkner supplied the Ebay sale page for item 6566270628 showing the ticket and a baseball card had been sold on October 3, 2005. The section, row and date of the ticket were listed but the seat was not listed on the Ebay page. Faulkner explained that he is not allowed to post the seat location on Ebay, but provided the seat number, 21.)

Faulkner said the officers walked him down the street to a black SUV parked near TGI Fridays bar and grill where one officer wrote him a summons, while the other officer walked over to a blond white female. The officer who was talking to the female apparently knew her as he was sharing a beer with her. After giving him a summons, Faulkner said the officers let him leave.

Faulkner said he went back to the location where he was supposed to meet Tim Roach. When Roach arrived, he advised Roach what had occurred and refunded his money for the tickets and the delivery fee. Faulkner said he was relieved as Roach told him that he had already obtained two tickets to the game for him and his son.

Faulkner said he then went to the game with the ticket he had in his back pocket and checked the seat for the ticket the officers had seized. There he observed the white female the officer had been speaking to in front of TGI Fridays.

Faulkner said he appeared in City Court on the date and time specified on the summons and was informed that his name was not on the docket. Faulkner said he contacted a friend who works with the Department and had them check and see what happened with his arrest. The subject told him there was no record of his arrest.

Tim Roach was contacted and he stated that he had purchased a baseball card and a baseball ticket to Game 2 of the Divisional Playoffs on Ebay from Jim Faulkner. Roach said he had planned to go to the game by himself, but when his son could go, he purchased two additional tickets from another individual over Ebay. (Verified through Ebay) Roach said that when he arrived at the prearranged meeting place he was met by Faulkner who apologized to him, stating that the ticket and baseball card he had purchased over Ebay had been seized by the police. Roach said Faulkner reimbursed him for the baseball ticket, baseball card and the cost of shipping. Roach said he then walked over to the stadium and arrived just prior to the game starting.

Andrew Toolen was contacted and he stated he had met his father's friend, Jim Faulkner, before Game 2 of the playoffs and received 2 tickets from him. Toolen said he and his brother gave Faulkner the face value of the tickets. As they were walking away, a plainclothes officer came up and displayed a badge. The subject began questioning Faulkner about their transaction. When the officer observed them standing nearby, the officer told them to move on as it did not concern them. Toolen did not witness anything further. Toolen said he and his brother then went to the stadium and arrived at the beginning of the first inning.

Timothy Toolen was contacted and corroborated his brother statement. Timothy Toolen believes they arrived at the stadium at the beginning of the first inning, but he could not be sure as he has attended numerous Cardinal games and he maybe confusing the time frame with another game.

Ray Battistini was contacted and confirmed that he gave Jim Faulkner two tickets to Game of the

playoffs. Battistini said he had purchased the tickets, however, the game was a day game and it interfered with work. Battistini asked Faulkner if he knew anyone who would like the tickets and Faulkner arranged to sell them to Michael Toolen's sons for face value. Battistini said he believes the tickets were in the bleachers, left field, Section 593. He said they were in the upper rows probably rows 24 or 25.

A preliminary investigation ascertained the incident was reported under CN 05/080010 and Officer Michael Ehnes, DSN 5628, is the reporting officer. Officer Thomas Kitchell, DSN 4974, is listed as the assisting officer. The report indicates that James Faulkner was arrested for "Scalping" at 119 Pine (It should be noted that the address of 119 Pine does not exist. This location would be on the Arch Grounds near the south legs of the Arch.) at 1447 hours on October 6, 2005. One baseball ticket to Game 2 of the Division Series, Section 228, was seized. According to the report, the ticket was placed in property custody. The report had a copy of the summons scanned, however, there was warrant application form scanned into the system. The summons had a complaint number; however, no tracking number was on the summons. A check with Rejis found no summons tracking number for James Faulkner. Assistant City Counselor David Miller was contacted and he checked the City Court files and did not find an City Court entry for James Faulkner, white male, DOB

The listed tickets were packaged and placed in the division property room.


