Subject: Sunshine Law Request

This letter is a request for copies of public records under the Missouri Sunshine Law. Pursuant to the provisions of Chapter 610 of the Missouri Revised Statutes, we request that you provide copies of any and all records in the possession of the Department of Corrections (DOC), regardless of who produced them, regarding witnesses to executions:

- 1. All records indicating or identifying invitees of the Director of the Department of Corrections to witness scheduled executions in the past 12 months;
- 2. All records indicating responses of invitees of the director of the department of corrections to witness scheduled executions in the past 12 months;
- 3. All records indicating requests by the public or the media to witness executions in the past 12 months;
- All records indicating consideration of the requests by the public or the media to witness executions in the past 12 months;
- 5. All records indicating responses to requests by the public or the media to witness executions in the past 12 months; and
- 6. All records indicating actual witnesses to executions in the past 12 months.

If any or part of this request is denied, please send a letter listing the specific exemptions upon which you rely for each denial and provide the contact information for the official to whom we may appeal. Mo. Rev. Stat. § 610.023.4. This request must "be acted upon as soon as possible, but in no event later than the end of the third business day following the date the request is received." Mo. Rev. Stat. § 610.023.3.

Because this records request is being submitted in the public interest and "is likely to contribute significantly to public understanding of the operation or activities" of your department, we ask that you waive any fees or charge a substantially reduced fee pursuant to Mo. Rev. Stat. § 610.026.1(1). However, should you decline to waive or reduce fees, proceed without further approval if the cost does not exceed \$ 50.00 and send an invoice with the records. If the cost will exceed \$50.00, please inform us of the cost in advance.
