

CONSENT TO RECOMMENDED DISCIPLINARY PUNISHMENT AND WAIVER OF BOARD TRIAL

Statement of Offense: (Give essential facts)

On or about October 24, 2006, Detective Thomas Kranz arrested or assisted in the arrest of a subject for ticket scalping. This arrest is reflected in a police report bearing complaint number 06-088087. The report indicates 1 ticket was seized as evidence in the case by Detective Kranz. Detective Kranz later gave this ticket to non-department employees, breaking the chain of evidence. This ticket was used by an individual to attend a World Series game.

On or about October 25, 2006, Detective Thomas Kranz arrested or assisted in the arrest of a subject for ticket scalping. This arrest is reflected in a police report bearing complaint number 06-088351. The report indicates 2 tickets were seized as evidence in the case by Detective Kranz. Detective Kranz later gave these 2 tickets to non-department employees, breaking the chain of evidence. These tickets were used by individuals to attend a World Series game.

On or about October 26, 2006, Detective Thomas Kranz arrested or assisted in the arrest of a subject for ticket scalping. This arrest is reflected in a police report bearing complaint number 06-088671. The report indicates 2 tickets were seized as evidence in the case by Officer Daniel Disterhaupt. Detective Kranz later gave these 2 tickets to non-department employees, breaking the chain of evidence. These tickets were used by individuals to attend a World Series game.

Detective Thomas Kranz is in violation of Police Manual Rule 7.004 (jj) which reads in applicable part, "(jj) Engaging in any conduct or act, on or off duty, which could bring discredit upon the Department or its personnel."

Recommended Disciplinary Punishment:

It is recommended Detective Thomas Kranz receive fourteen (14) days of Disciplinary Suspension and be reduced in rank to Probationary Police Officer for a period of not less than one year.
