In reference to an investigation conducted under IAD File #06/276, the complainant, Eric Johnson, informed Sgt. Sheila Pearson, an Internal Affairs Investigator, that the undercover detectives who arrested him may have used the St. Louis Cardinals World Series Tickets which had been seized from him. Mr. Johnson stated he was nearby when one of the detectives made a telephone call informing the person contacted that he had tickets to the game and asked whether the person wanted to attend the game. As a result of this additional allegation, a preliminary audit was conducted for complaint #06-088953 to determine whether the tickets had in fact been used. This investigation disclosed that the two tickets seized under this report had been scanned

by the Cardinals organization after the arrest of Mr. Johnson. Due to this discovery, a comprehensive audit was conducted regarding all tickets seized by the Vice/Narcotics Division, throughout the scalping detail for the World Series Games (10/24/06 - 10/27/06).

As a result of the aforementioned audit, an investigation was conducted under IAD File #07/068. The World Series Scalping Detail consisted of one lieutenant, three sergeants and 18 detectives who completed a total of forty-four ticket scalping reports and seized ninety-eight tickets. From this audit and the subsequent interviews, it was learned that eight detectives gave thirty-four of the seized tickets, from thirteen arrests, to various family members and friends to allow them admittance into several of the games. All of the tickets related to these thirteen cases were located. It was determined that thirty-one of these tickets had been scanned by the St. Louis Cardinals organization, after the time of arrest indicated on the respective reports. Per the Cardinals organization, three seized tickets had not been scanned, however, through the statements of the detectives, it was learned that the tickets had in fact been used. The Cardinals organization added that due to the high volume of fans entering the stadium, human error could be responsible for the discrepancies.

As a result of the interviews conducted with the involved detectives from the Vice/Narcotics division, it was determined that three detectives had knowledge of or assisted in allowing family members and friends to utilize the World Series Tickets. It was also determined that one detective, on three occasions, failed to properly package evidence and on a separate occasion, failed to locate the ticket from the arrest.

The supervision assigned to the scalping detail consisted of one lieutenant and three sergeants. On March 19, 2007 an inspection was conducted of the Vice/Narcotics division. During this inspection, numerous procedural violations were noted and an overall absence of adequate administrative procedures was revealed.

The investigation determined that Det, Fred Lathan assisted Det, Phillip Edmond on 10/24/06 at 17:30, in the arrest of Jeffrey Bradshaw per complaint #06-088056 and also on 10/25/06 at 16:45, in the arrest of Mylan Hall per complaint #06-088344. The Internal Affairs Division interviewed Det. Edmond, the author of both reports. During this interview, Edmond admitted that on both occasions he had advised Lathan that he intended to give the tickets to his fiancé, who along with her girlfriend would attend the games. Lathan responded that it would not be a good idea, and not worth the risk of getting in trouble, however, Edmond gave the tickets away, unbeknownst to Lathan.

It is alleged that Det. Fred Lathan violated Police Manual Rule 9, subsection 9.001 (i), which reads in applicable part "A Department member shall not fail to notify his superior of information concerning police matters that come into his possession."

FINDINGS A:

An examination of the police report and the corresponding evidence bag for complaint #06-088056, indicated that three World Series Tickets were seized and determined to be from section #431, row #7, seat #'s 12, 13 and 14. Nancy Landa, Ticket Sale Representative for the St. Louis Cardinals, advised that two of the three tickets (seats 13 & 14) had been scanned on 10/27/06 at 18:31 hours. Also examined were the police report and evidence bag for complaint #06-088344. According to this report, two tickets were seized as evidence. The evidence envelope was found to contain two World Series Tickets, section #431, row #7, seat #'s 15 and 16. Nancy Landa advised that these two tickets had also been scanned on 10/27/06 at 18:31 hours.

Det. Fred Lathan was interviewed and stated that he had advised Edmond that it was a bad idea to do something like that. Lathan did not take any action after having the conversation with Edmond and assumed that Edmond had taken heed to his advice and placed the tickets into evidence.

ALLEGATION B:

The investigation determined that Det. Jason Scheel assisted Det. Phillip Menendez on 10/25/06 at 15:00, in the arrest of Demond Screws, Jermaine Carter and Lonell Harris at 100 S. Broadway per complaint #06-088349. Det. Scheel also assisted Det. Phillip Menendez on 10/26/06 at 18:00, in the arrest of Steven Eaves at 100 S. Broadway per complaint# 06-088715. During an interview with Scheel, he stated that at the time of both arrests, he was aware of Menendez's intentions to give tickets to his family members. Scheel added that he was the seizing officer on the arrest bearing complaint #06-088349, and upon Menendez asking for the tickets, he did not object and complied with the request.

Det. Jason Scheel is alleged to be in violation of Police Manual Rule 3, subsection 3.115 (k), which reads in applicable part, "shall be accountable for the securing, receipting and proper transporting of all evidence and property coming into his custody."

FINDINGS B:

An examination of the police report and evidence envelope for complaint #06-088349 indicated six World Series Tickets were seized and determined to be from Section #172, Row #16, Seat #'s 9 and 10; Section #337, row #1, Seat #'s 7 and 8; and Section #441, Row #6, Seat #'s 5 and 6. Landa advised that all of the tickets had been scanned at the stadium on 10/27/06 between the hours of 17:29 - 19:07. Also examined were the police report and evidence envelope for complaint# 06-088715. The evidence envelope was found to contain 4 World Series Tickets; section #235, row #1, seat #4; section #452, row #3, seat #'s 15, 16 and 17. Landa further advised that these tickets had been scanned on 10/26/06 between the hours of 18:01-20:10.

Det. Scheel was interviewed on 03/15/06. During the interview, he admitted that after having seized the tickets on 10/25/06, Det. Menendez requested that the tickets be given to him (Menendez) to allow his family entrance into the World Series Game that night. Scheel added that on 10/26/06, Menendez again told him he intended to give the tickets to his family members. Scheel added that at the time of the discussions, he did not object to Det. Menendez's intentions.

ALLEGATION C:

The investigation determined that Det. Robert Singh assisted Det. Michael Ehnes on 10/25/06 at 14:38, in the arrest of Melvin Hackett at 100 S. Broadway per complaint #06-088366. Det. Singh was the arresting officer on 10/27/06 at 16:45, for suspect Eric Johnson at 100 S. Broadway, per complaint #06-088953. Singh stated during his interview, that on 10/25/06 and on 10/27/06, Ehnes advised him (Singh) that he had intended to give the tickets, which had just been seized, to his wife and kids to attend the games.

Det. Robert Singh is alleged to be in violation of Police Manual Rule 3, subsection 3.115 (k), which reads in applicable part, "shall be accountable for the securing, receipting and proper transporting of all evidence and property coming into his custody."

FINDINGS C:

The corresponding report and evidence bag for complaint #06-088366, indicated that two World Series Tickets were seized and determined to be from section #139, row #16, seat #'s 9 and 10. Landa advised that both tickets (seats 9 and 10) had been scanned on 10/27/06 at 19:18. Also reviewed were the report and evidence bag from complaint# 06-088953. It was determined by Landa that these two World Series Tickets, section #1327 Travelor 22 Progressian #25 Progressian Progressian Formattic: scanned on 10/27/06 at 18:24.

Det. Robert Singh was interviewed and stated that after the arrest on 10/25/06, Ehnes stated he had intended to allow his family to enter the World Series Game that night. Singh further stated on 10/27/06, after completing his arrest, Ehnes requested that he be given the seized tickets to give to his wife and kids to attend the game that day. Singh then gave Ehnes the two tickets from his (Singh's) arrest. Singh added that at the time of the request, he did not object to Det. Ehnes's request.

ALLEGATION D:

On 10/24/06 at 20:51, Det. Mark Biondolino effected the arrest of suspect Michael Fincham at 101 S. 4th Street per complaint #06-088099. The property section of the report indicates that two World Series, Game 3 Tickets were seized. The corresponding evidence envelope bearing complaint# 06-088099, was found to contain one Post Season, League Home Game 2, section #167, row #21, seat #22.

On 10/25/06 at 16:07, Det. Mark Biondolino arrested suspect Donnell Fletcher at 401 Clark Ave, per complaint #06-088355. The property section of the report indicates that one standing-room-only ticket, gate #50, with a price of \$50.00 was seized. The corresponding evidence envelope bearing complaint #06-088355 contained two National League Championship Series Tickets, section #450, row #11, seat #'s 28 and 29.

On 10/26/06 at 15:20, Det. Mark Biondolino also arrested suspect Shawn Blacknoll at 400 Clark Ave, per complaint #06-088654. The report indicates that no tickets were seized during the arrest, however, there is a corresponding evidence envelope bearing complaint #06-088654, containing two World Series, Game 3 Tickets, section #SBP, row #3, seat #'s 5 and 6.

It is alleged that Officer Mark Biondolino violated Police Manual Rule 3, subsection 3.115(k), which reads in applicable part "shall be accountable for the securing, receipting and proper transporting of all evidence and property coming into his custody."

FINDINGS D:

It has been determined that Det. Biondolino incorrectly packaged evidence from arrest report #06-088099 and placed it into an evidence bag indicating complaint #06-088654 and similarly placed the corresponding evidence from complaint #06-088099 into an evidence bag bearing complaint #06-088654. Per the arrest report from complaint #06-088654, there were no tickets seized. Additionally, the one standing-room-only ticket seized per complaint #06-088355 has not been located. The two National League Championship Series Tickets located in the corresponding evidence bag, appear to have been seized during an arrest conducted by Biondolino on 10/17/06 per complaint #06-086046. During an interview with Det. Biondolino he could give no explanation for the incorrect packaging of evidence nor could be account for the missing standing-room-only ticket.

Detective Sergeant Anthony Boone was assigned to supervise five undercover detectives during the World Series Scalping Detail on October 24 – 27, 2006. It was alleged that several detectives provided family members and friends with seized tickets to attend World Series

During the investigation of the World Series Detail, an inspection of the Vice/Narcotics division was conducted. An examination of the safe and log book maintained by Detective Sergeant Anthony Boone cited numerous instances wherein seized money that was indicated in the log book as having been forwarded to "Asset Forfeiture" and valued more than \$200.00 but less than \$2,000.00, remained in the safe beyond forty-eight hours. There were also several instances wherein seized money that was indicated in the log book as having been forwarded to "Asset Forfeiture" and valued more than \$2,000.00, remained in the safe for an extended period of time, rather than having been relinquished to Asset Forfeiture at the location of seizure.

A REJIS inquiry was conducted of the nine arrests completed by the undercover detectives under the direct supervision of Sgt. Boone. It was determined that several detectives failed to conduct criminal background inquiries and warrant/"wanted" inquiries on the suspects.

It is alleged that Sgt. Anthony Boone violated Police Manual Rule 4, Bureau of Investigation, subsection 4.031, Responsibilities of Section Supervisors, which reads, "Each section supervisor shall be responsible to his division commander for the general appearance, good order and discipline, and proper attention to duties of the personnel under his supervision. He shall be responsible for the efficient operation of the section under his supervision and shall carefully direct the activities of his personnel to assure proper performance of their duties, maintenance of discipline, and cooperative action with other members of the Department."

FINDINGS E:

It has been determined through investigation and interviews, that the following two undercover detectives under the direct supervision of Sgt. Boone, provided family members and friends with twelve seized tickets to attend World Series Games. Special Order 90-S-12(I)(C)(8) mandates that evidence shall not pass through more hands than absolutely necessary.

Detective Wendell Ishmon, DSN 5037, admitted that after arresting suspect Kenneth Lee per report #06-088060, he allowed his son and his son's mother to use two seized tickets to attend a World Series Game.

Detective Phillip Menendez, DSN 3920, admitted that after arresting Steven Eaves, per report #06-088349 and Demond Screws, per report #06-088715, he allowed numerous family members to use a total of ten tickets to gain access into two World Series Games.

Through examination of the Vice/Narcotics division, it has been determined on the following four occasions Sgt. Boone allowed money valued over \$2,000.00 to remain in the safe for an extended time frame prior to being relinquished to Asset Forfeiture. Special Order 2000-S-3 (B)(5) mandates that seizures of currency assets over \$2000.00 are to be relinquished to Asset Forfeiture at the scene of seizure.

An audit was conducted of the arrests effected by the seven undercover detectives under the direct supervision of Sgt. Crews. It was determined that several reports with his approval contained discrepancies and missing summons numbers and corresponding warrant applications had not been completed.

A REMS inquiry was conducted of the arrests completed by the undercover detectives under the direct supervision of Sgt. Crews. It was determined that several detectives failed to conduct criminal history inquiries and warrant/"wanted" inquiries on the suspects.

It is alleged that Sgt. Joseph Crews violated Police Manual Rule 4, Bureau of Investigation, subsection 4.031, Responsibilities of Section Supervisors, which reads, "Each section supervisor shall be responsible to his division commander for the general appearance, good order and discipline, and proper attention to duties of the personnel under his supervision. He shall be responsible for the efficient operation of the section under his supervision and shall carefully direct the activities of his personnel to assure proper performance of their duties, maintenance of discipline, and cooperative action with other members of the Department."

FINDINGS F:

It has been determined through investigation and interviews, that the following three undercover detectives under the direct supervision of Sgt. Crews, provided family members and friends with eleven seized tickets to attend World Series Games. Special Order 90-S-12(I)(C)(8) mandates that evidence shall not pass through more hands than absolutely necessary.

Detective Michael Ehnes, DSN 5628, admitted that after the arrest of suspect Melvin Hackett per report #06-088366 and that of Eric Johnson per report #06-088953, he allowed his wife and sons to use a total of four seized tickets to attend a World Series Game.

Detective Thomas Kranz, DSN 4215, admitted after completing the arrests of Jeremiah Johnson per report #06-088087, Matthew Eversgerd per report #06-088671, and Takih Chester per report #06-088351, he allowed a total of five seized tickets to be utilized by family members to attend three World Series Games.

Detective Thomas Kitchell, DSN 4974, admitted after effecting the arrest of Kenneth Lee per report #06088060, he allowed a friend to utilize two seized tickets to attend a World Series Game.

An audit of the arrest reports approved by Sgt. Crews determined the following two reports contained discrepancies within the property and narrative sections of the reports. Special Order 9-01(III)(A)(2)(a-b) mandates that the Sergeant/Supervisor will review reports for accuracy, completeness, spelling and grammar.

An audit was conducted of the arrests effected by the six undercover detectives under the direct supervision of Sgt. Morici. It was determined that several reports with his approval contained discrepancies and missing summons numbers and corresponding warrant applications had not been completed.

A REJIS inquiry was also conducted of the arrests completed by the undercover detectives under the direct supervision of Sgt. Morici. It was determined that several detectives failed to obtain criminal history inquiries and warrant/"wanted" inquiries on the suspects.

This investigation determined one detective under the direct supervision of Sgt. Morici, on several occasions during October 24-27, 2006, improperly packaged evidence and on one occasion failed to locate evidence (Refer to Allegation D of this ARTS).

It is alleged that Sgt. Joseph Morici violated Police Manual Rule 4, Bureau of Investigation, subsection 4.031, Responsibilities of Section Supervisors, which reads, "Each section supervisor shall be responsible to his division commander for the general appearance, good order and discipline, and proper attention to duties of the personnel under his supervision. Detective Phillip Edmond, DSN 3679, admitted after completing the arrests of Mylan Hall per report #06-088344, and Jeffrey Bradshaw per report #06-088056, he allowed a total of four seized tickets to be utilized by his girlfriend and her friend to attend a World Series Game.

Detective Joseph Somogye, DSN 3913, admitted after effecting the arrest of Willie Miller per report #06-088346, he allowed his wife and sons to utilize five seized tickets to attend two World Series Games.

An audit of the fifteen arrest reports approved by Sgt. Morici determined the following five reports contained discrepancies within the property and the narrative sections of the reports. Special Order 9-01(III)(A)(2)(a-b) mandates that the Sergeant/Supervisor will review reports for accuracy, completeness, spelling and grammar.

ALLEGATION H:

Lieutenant Michael Deeba, Commander of the Vice/Narcotics Division, was assigned to supervise the World Series Scalping Detail on October 24 – 27, 2006. Three sergeants and eighteen detectives assigned to the detail were also permanently assigned to the Vice/Narcotics division. During this detail a total of forty-four police reports, from which ninety-eight World Series Tickets were seized. It was alleged that detectives under his command, permitted family members and friends to utilize seized tickets to enter several World Series Games. Subsequently, an investigation into this allegation, an examination of related police reports and an audit of the Vice/Narcotics Division was conducted.

It is alleged that Lt. Michael Deeba is in violation of Police Manual Rule 4, Bureau of Investigation, subsection 4.021, which reads, "Each division commander, in consultation with each section supervisor under his command, shall establish such operating rules and procedures as he believes are required for the efficient operation of his section." Such operating rules shall be prepared in writing... and shall be on file in the office of the division commander..."

FINDINGS H:

Through investigation and interviews it has been determined that eighteen detectives under the command of Lt. Deeba, completed forty-four tickets scalping reports. Eight detectives admitted allowing family members and friends to utilize a total of thirty-four seized tickets, from thirteen cases, for entrance into several World Series Games. An inspection of the forty-four reports revealed that eight reports contained inaccurate information. A REJIS inquiry concluded that criminal background inquiries and warrant/"wanted" inquiries were not conducted in twenty-five cases. Additionally, REJIS and the Office of the City Counselor determined that in seven cases, detectives did not obtain summons numbers, failed to complete warrant applications and failed to specify court dates on the summonses.

An audit of the Vice/Narcotics Division safe and log book indicated continuous violations of Asset Forfeiture procedures. On four occasions money valued over \$2,000.00 remained in the safe from twelve days — six months (Refer to Allegation E and Finding E). In twelve instances money valued under \$2,000.00 remained in the safe from 5 days to 6 months and beyond.

Captain John Hayden, Commander of IAD, along with Deputy Commander, Lt. Jack Huelsmann, interviewed Lt. Michael Deeba with respect to the 2006 World Series Ticket Scalping Detail on March 21, 2007. During the interview, Lt. Deeba admitted that he had no written procedures established to ensure the efficient operation of the Ticket Scalping Detail and also admitted that he had no written procedures established to ensure the efficient operation of the Vice Narcotics Division. Lt. Deeba mentioned that the only written policies observed in the Vice Narcotics Division were those contained within general Special Orders of the Police Department.
