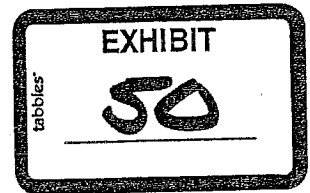

**Summary** INCIDENT IN WHICH NUMEROUS OFFICERS ASSIGNED TO THE VICE/NARCOTICS DIVISION MADE "TICKET SCALPING" ARRESTS DURING THE 2006 WORLD SERIES, SEIZING VARIOUS TICKETS AS EVIDENCE. THEY THEN GAVE THE TICKETS TO VARIOUS NON-DEPARTMENT EMPLOYEES TO USE, BREAKING THE CHAIN OF CUSTODY; SEVERAL SERGEANTS FAILED TO PROPERLY PERFORM THEIR DUTIES; LT. DEEBA, UNIT COMMANDER, FAILED TO ESTABLISH OPERATING RULES AND PROCEDURES FOR THE EFFICIENT OPERATION OF THE UNIT. OFFICERS RECEIVED 14-DAY SUSPENSION AND DEMOTION.
