had a safe. I don't think sergeant, I don't know if Sgt. Kuntz had

access to it or not. I don't know.

SGT. PEARSON: Ok. So with these tickets your partner, who was your partner at

with this arrest?

SGT. PEARSON:

Ok. At the time of arrest or after the time of arrest was he uh, where was he when you um gave these tickets to a friend?

I honestly couldn't tell you. We were um, Wendell's not my normal partner and we kind of just work just in groups down there. Um, we were two, four, six at a time all over so I, I don't know if Wendell was there when I gave them to Bill or if he was or who was there to be honest with you.

SGT. PEARSON:

Did he have knowledge that you were giving them to a friend?

I can't say what he did know or didn't know, but I think just general consensus I think, I didn't tell him, we never, we didn't discuss it I didn't say here hey this is what I'm gonna do, but I don't know if he was there or not if he saw it or if he saw other people or what.

SGT. PEARSON:

So you never actually had the discussion that this is what you were gonna do with the tickets. He didn't ask you and you didn't volunteer the information. Is that, am I taking that correctly?

Correct.

Ok. Let me ask you when you say uh he just kind of knew, was this, had there ever been talk in the unit on this, this was possible that you could do this with the tickets?

your mouth, but some would say it was common knowledge that this could be done. Is that, is that, would you say that's a fair assessment that um it was common knowledge among the unit that

you could um do that with these tickets?

anybody in our unit that this was what I was gonna do or no one

came to me and said this is what you could do.

SGT. PEARSON: You never overhead, just general speaking, you never heard

anyone speaking of that?

P.O. KITCHELL: No.

SGT. PEARSON: So when did it, for sure, when did your partner with this arrest um

know that this is what had been done with the tickets?

P.O. KITCHELL: Sometimes afterwards, mainly when all this, when uh (inaudible)

started coming down I think this when he really, really, we all kind

of got together and said well what happened here and what happened here, you know, I think everybody just kind of talked and (inaudible) about it. That's when I know he officially knew. I mean I never, until the complaint came down, sat down with

Wendell and said anything to him personally.

SGT. PEARSON: So that was the first time you had the conversation with him?

P.O. KITCHELL: Well it was with everybody, yeah.

SGT. PEARSON: So you still haven't had a direct conversation, you're saying just in

a group way it was discovered?

got the rumors down that we were being investigated for this we kind of all got together and said you know pull the reports and see what's going on and uh that's when uh Sgt. Kuntz came down and
