New Program Launch

Education Development Section (EDU)

The Legal Department is embarking upon a new education initiative rooted in the delivery of legal workshops covering the law, public policy, career goals, general education, and other related subject matter. This effort is "designed for interns and by interns."

The next three months (June-August 2018) will be dedicated to activities involving initiating, planning, and implementation of 50 workshops assigned across a remote team of 10 Workshop Coordinators (interns).

The Legal Seminar Series has a tentative launch date of September 2018.

New Program Launch

Digital & Multimedia Evidence Section (DME)

The Digital & Multimedia section will provide Digital Multimedia Evidence (DME) examination activities involving the collection, cataloguing, and review of digital and multimedia evidence received via the Mobile Justice App and resulting from protest events.

The purpose of a DME examination is to analyze digital data for the purpose of identification, collection, and preservation of digital evidence in the event of legal action. Types of reviews will include digital evidence from computers, cell phones, tablets CD/DVDs, USB drives, and other digital data storage devices.

Summer interns Natalie Geismar and Mary Grace Gorman, both of Wash. U, have been assigned to the DME Section.









ANNUAL NEW INTERN ORIENTATION & TRAINING

For the second summer in a row, the Legal Department conducted annual New Intern Orientation and Training.
