COMPLAINT

I. Introduction

- 1. Plaintiff, Jeffrey W. Rogers, has been incarcerated by the State of Missouri since 1995 and is currently at Jefferson City Correctional Center (hereinafter "JCCC").
- 2. Defendants have refused to allow Rogers to have his electric wheelchair, currently with his family, delivered to him at JCCC for his use at his own expense.

3. This is a lawsuit under the American with Disabilities Act (42 USC §§ 12131-12134) and Section 504 of the Rehabilitation Act (29 U.S.C. §794), seeking only injunctive relief to compel Defendants to allow delivery and use (at his own expense) of Rogers's personal electric wheelchair within DOC facilities.

II. Jurisdiction and Venue

- 4. This Court has jurisdiction under 28 U.S.C. §§ 1331 and 2201 and 29 U.S.C. §794a.
- 5. Venue is proper in this Court pursuant to 28 U.S.C. § 1391(b)(2) and Local Rule 3.1(a)(2). A substantial part of the events or omissions giving rise to the claim occurred in Cole County, Missouri.

III. Parties

- 6. Plaintiff, Rogers, is a citizen of the United States citizen and an inmate at JCCC.
- 7. Defendant Missouri Department of Corrections (hereinafter "DOC") is a state executive agency that has the power to sue and be sued pursuant to Mo.Rev.Stat. § 217.020.
- 8. Defendant George Lombardi is the Director of DOC. He is sued in his official capacity.
- 9. Defendant Steve Long is the Division Director of the Division of Adult Institutions of DOC. He is sued in his official capacity.
- 10. Defendant Matt Sturm is the Deputy Division Director of the Division of Adult Institutions of DOC. He is sued in his official capacity.
- 11. Defendant Dave Dormire is the Warden for JCCC. He is sued in his official capacity.

IV. Facts

- 12. Rogers has been incarcerated in the Missouri DOC since 1995.
- 13. Rogers has a physical impairment that substantially limits one or more of the major life activities.
- 14. Rogers has a record of a physical impairment that substantially limits one or more of the major life activities, has been regarded as having such an impairment, or both.
- 15. Rogers use of a non-electric wheelchair and inmate "pusher" does not allow him the full opportunity to participate in services, programs, and activities at JCCC, without discrimination, as would be the case if he had an electric wheelchair.
- 16. Services, programs, and activities include the dining hall; medical services; educational programs; use of the library; use of the gym and the "yard" for recreation; social meetings; religious activities and functions; etc.
- 17. Defendants have instead insisted that they "would continue to provide a [non-electric] wheelchair and pusher" and that this is sufficient.
- 18. At least one other person incarcerated by DOC, and currently at JCCC, has a personal electric wheelchair.
- 19. Rogers has exhausted administrative remedies in his effort to get his personal electric wheelchair delivered to him for his use and at his cost.
- 20. These denials are in contravention to both the American with Disabilities Act, 42 U.S.C. §§ 12131-12134 and Section 504 of the Rehabilitation Act (29 U.S.C. §794).
- 21. The Defendants' refusal to accommodate Rogers's disability-related needs, constitutes exclusion from participation in, or denial of the benefits of, the prison's services, programs, or activities.

Count I

Violation of Americans with Disabilities Act

- 22. Plaintiff repeats, re-alleges, and incorporates by reference the allegations in the foregoing paragraphs of this Complaint as fully set forth herein.
- 23. Subtitle A of Title II of the Americans with Disabilities Act (ADA) prohibits public entities from discriminating against persons with disabilities in their programs, services, and activities. 42 U.S.C. §§ 12131-12134. Regulations implementing subtitle A are codified at 28 C.F.R. part 35.
- 24. Title II's definition of "public entity" includes any state or local government or "any department, agency... or other instrumentality" of a state or local government. 42 U.S.C. § 12131(1)(A), (B).
- 25. Defendant DOC is a "public entity" within the meaning of 42 U.S.C. § 12131(1)(A) and 28 C.F.R. § 35.104.
- 26. All Defendants are officials responsible for the operation of public entities for the purposes of Title II.
- 27. Plaintiff has a disability within the meaning of 42 U.S.C. § 12102(1) and 28 C.F.R. § 35.104.
- 28. Plaintiff is a "qualified individual with a disability" within the meaning of 42 U.S.C. § 12131(2) and 28 C.F.R. § 35.104 because he meets the essential eligibility requirements for the receipt of services or the participation in programs or activities provided by Defendants other than the fact that he requires reasonable modifications to rules, policies, or practices, the removal of barriers, or the provision of auxiliary aids and services.

- 29. Defendants subject Plaintiff to discrimination by not allowing him to have his electric wheelchair delivered to him. This denial and discrimination violates 42 U.S.C. § 12132 (and the regulations promulgated under it 28 C.F.R. Part 35) which states: "Subject to the provisions of this subchapter, no qualified individual with a disability shall, by reason of such disability, be excluded from participation in or be denied the benefits of the services, programs, or activities of a public entity, or be subjected to discrimination by any such entity."
- 30. As a result of Defendants' violations of the ADA and its implementing regulations, Defendants are liable to Plaintiff for injunctive and declaratory relief pursuant to 42 U.S.C. § 12133.

WHEREFORE, the Plaintiff prays this Court:

- A. Enter declaratory judgment finding Defendants' denial of Plaintiff's request to have his electric wheelchair delivered to him at JCCC for his use violates the Americans with Disabilities Act;
- B. Issue appropriate injunctions compelling Defendants to allow delivery and use of Plaintiff's personal electric wheelchair;
- C. Issue appropriate injunctions to prevent the future deprivation of Plaintiff's rights;
- D. Award Plaintiff's costs, including reasonable attorneys' fees under 42 U.S.C.§ 12133; 12205, 29 U.S.C. § 794; and other relevant provisions of law; and
- E. Allow such other and further relief to which Plaintiff may be entitled.

Count II

Violation of §504 of the Rehabilitation Act

- 31. Plaintiff repeats, re-alleges, and incorporates by reference the allegations in the foregoing paragraphs of this Complaint as fully set forth herein.
- 32. Section 504 of the Rehabilitation Act of 1973, 29 U.S.C. § 794 (Section 504), provides, *inter alia.*, "No otherwise qualified individual with a disability in the United States ... shall, solely by reason of her or his disability, be excluded from the participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance or under any program or activity conducted by any Executive agency..."
- 33. Plaintiff is a "qualified individual with a disability" as defined by 29 U.S.C. §705(20).
- 34. Plaintiff meets the essential eligibility requirements for the receipt of services or the participation in programs or activities provided by Defendants other than the fact that he requires reasonable modifications to rules, policies, or practices, the removal of... barriers, or the provision of auxiliary aids and services.
- 35. Defendants are a "program or activity" that receive federal assistance for the purposes of § 504. 29 U.S.C. §794(b).
- 36. Defendants discriminate against Plaintiff by not allowing delivery and use of his personal electric wheelchair.
- 37. As a result of Defendants' violations of § 504 of the Rehabilitation Act of 1973, Defendants are liable to Plaintiff for injunctive and declaratory relief pursuant to 29 U.S.C. §794a.

WHEREFORE, the Plaintiff prays this Court:

- A. Enter declaratory judgment finding Defendants' denial of Plaintiff's request to have his electric wheelchair delivered to him at JCCC for his use violates \$504 of the Rehabilitation Act;
- B. Issue appropriate injunctions compelling Defendants to allow delivery and use of Plaintiff's personal electric wheelchair;
- C. Issue appropriate injunctions to prevent the future deprivation of Plaintiff's rights;
- D. Award Plaintiff's costs, including reasonable attorneys' fees under 29 U.S.C.§ 794a and other relevant provisions of law; and
- E. Allow such other and further relief to which Plaintiff may be entitled.
