WHAT RIGHTS DO I HAVE IN PRISON AND JAIL?

The following are some civil rights that are protected in prison/jail. The law is always evolving, so if you have access to the prison's law library, stay up to date with new developments.

- Humane conditions and facilities
- Adequate medical and mental health care: It is important to record all of your requests for medical care and complaints to guards and medical professionals, as they can help prove that prison officials were aware of and ignored your medical needs.
- Freedom from discrimination
- Freedom from sexual abuse/harassment
- Freedom from assault
- Nutrition: You are entitled to healthy food and accommodations if you have a special diet for medical or religious reasons.
- American with Disabilities Act (ADA)
 Protections: You have the right to medical devices such as wheelchairs or canes, sign language interpreters, classification decisions, medical appointments, and educational/vocational programs.
- Express complaints or file grievances regarding conditions or treatment
- Send and receive mail: Prison staff can open non-privileged mail (letters from friends/relatives/businesses) outside of your presence without probable cause or a warrant, but can only open mail in your presence that is clearly marked as privileged (mail to and from attorneys and legal organizations) in your presence.

- Trans Rights: Prisons are required to provide treatment for gender dysphoria and failure to evaluate and/or taking too long to do so is a violation. They should also provide protection against threats and consider your safety when placing you in a prison.
- Practice religion

WHAT CAN I DO IF MY RIGHTS HAVE BEEN VIOLATED?

Step 1: File a Grievance

File an Informal Resolution Request (IRR) through your prison's grievance system within 15 days of the incident. Your prison will have 40 days to respond upon receiving your IRR. If the response is unsatisfactory, follow your prison's grievance system to submit an appeal.

Step 2: Contact the ACLU or another advocacy organization

Your complaint must include your full name, address, DOC, or BOP number, and a clear explanation of the incident that occurred. The following questions should be addressed:

 How were your rights violated? (please include dates, places, documentation, and names of the people involved)

- What steps have you taken to solve the problem? We strongly encourage that you file an IRR before you submit a complaint to us. Attach your grievance and the response to your complaint.
- Do you have an attorney?
